Frequently Asked Questions

When is a Report and Consent under Section 29A required?

A Report and Consent under Section 29A is required if any of the following apply:

- If a planning permit for demolition is required under the *Planning and Environment Act 1987*, it must be approved before Council consent can be provided. To check if a planning permit is required contact Statutory Planning on (03) 5950 1010. If a planning permit for demolition is required and is not obtained before submitting this application, a refund will not be provided. A separate request for report and consent to the Executive Director, Heritage Victoria, is required for an application to demolish or alter a building that is on a register established under the *Heritage Act 1995*.
- Proposed demolition works, together with any other demolition completed or permitted within the period of 3 years immediately preceding the date of the application, would amount to the demolition of more than half the volume of the building as it existed at the date of the first building permit to be issued within that period.
- The demolition is of any part of the façade* of a building if that façade faces a street**.

*Façade means:

- (a) an external wall, including any verandah, balcony or balustrade or architectural feature attached to or forming part of an external wall; or
- (b) a part of a roof; or
- (c) a chimney—

that faces a street and at least part of which is visible from the street it faces.

**Street includes: road, highway, carriageway, square and court.

The demolition of a freestanding shed not constructed of masonry and less than 40m² in floor area is exempt from the need for a Report and Consent under Section 29A.

What information should be submitted with a request?

- The completed request form (as overleaf) including a concise description of the demolition proposal.
- A copy of an existing site plan with clear marking of the structures to be altered or removed (including any demolition, past and approved, during the previous 3 years).
- An attached cheque or receipt number for the fee of **\$85.20**. Pay by phone: 1300 850 600 or 5950 1060 or in person or at any Shire Office (listed overleaf).
- A copy of the full application for the associated building permit.
- Arrangements that have been made for a Council officer inspection (e.g. unlocking of gates, securing of dogs and notification of residents).
- A recent photograph including date taken.
- Incomplete applications will be refused. No refund will be provided.

How long will it take?

- Council will provide a response within 15 business days after the day the application is received along with payment and all documentation. Please note, the day the request is lodged is not included in the 15 business days.
- After this time, if a response has not been received, Council is deemed to have consented to the application, except where a planning permit is required for the demolition but has not been obtained. In that case, Council is deemed to have refused its consent (Schedule 2 of the *Building Act 1993*).

For how long is a Report and Consent valid?

Report and Consent remains valid for 12 months from the date of issue.
