

**LOCAL LAW PERMIT APPLICATION

For placement of bins and skips in public streets/thoroughfares/  
roads and reserves within the Mornington Peninsula Shire



- This permit is for a seven (7) day period or part thereof per skip/bin on a site at any time.
- If a skip/bin is to be placed longer than the seven (7) day period a new application is required to be completed for each consecutive seven (7) day period, for each site address.
- Please note Skip Bins cannot be placed until permit is approved.
