To ensure the Responsible Authority considers your objection, ensure the authority received it by the due date on the notice. An acknowledgement letter will be forwarded to you upon receipt of your objection.

Further important information:

- If you object prior to the Responsible Authority determining the application, the Responsible Authority will notify you of its decision.
- If the application is to be determined at a Council Meeting, a copy of your objection will form part of the report which is available for public viewing.
- If, despite your objection, the Responsible Authority decides to Grant a Permit, you can appeal against the decision. Details of appeal procedures are set on the back of a Notice of Decision which you will receive provided you have lodged the objection prior to the determination of the application.
- If the Responsible Authority refuses the application, the applicant can also appeal. The provisions are set out on the Refusal to Grant a Planning Permit which will be issued at that time.
