General [Rule 4 Unnecessary content]

- Encourage non-residential uses to be located: [13.07-1L S]
 - Adjacent or close to business zones in a way that complements the relevant activity centre. Major non-residential uses serving catchments beyond the local level should be located in commercial zones. [13.07-1L S]
 - ~~– In areas that are appropriate to the intensity and scale of the proposed use and in locations that will have minimal impact on the amenity of the local area and nearby residential properties.~~ [Rule 3 17.02-2S Duplication]
 - Close to public transport stops. [13.07-1L S]
 - In locations that avoid the generation of additional through traffic on residential streets.
